He went on to the Massachusetts Appeals Court, where he heard hundreds of civil matters, authored more than 100 civil decisions on a wide array of issues, and saw firsthand how often a hard-won verdict is only the beginning of a longer fight.

Judge Brennan served as a Regional Administrative Justice, a role in which he informally mediated and helped resolve hundreds of workplace disputes. Judge Brennan has long invested in the profession as a teacher, spending years as an adjunct law professor and serving as a faculty member with the National Institute for Trial Advocacy, where he trained lawyers in trial skills, along with frequent panel and presentation roles across the bench and bar.
